<u>Tribal and Indian Preference</u>: To be considered for Tribal/Indian Preference in hiring, applicants must submit a valid Certificate of Indian Blood ("CIB") and/or Certificate Degree of Indian Blood ("CDIB") with their Employment Application and supporting documents. *Tribal Indian Preference will not be given if a CIB and/or CDIB is not submitted.*

<u>Driver's License Requirement:</u> Applicants who apply for a job position that require a valid driver's license must submit a copy of their driver's license with their application.
