She requested for all of the cards that were returned from prisons if the Nation could send a check to the prisons instead so they could all receive the \$75 to be placed on their books for food.

# c. MARKET PLACE UPDATE - Ricardo Pacheco & Jim Simons

A report was provided by Jim Simons. We are waiting on banners to arrive and then there will be a partial opening for the gas pumps only. We have completed the fire protection upgrades in the amount of \$5,000. This is not part of the insurance coverage. We will be switching our surveillance company from Wired-Up to B&W. There will be annual inspections and the fire extinguishers will be checked. There will be an inspection by Indian Health Service on January 15<sup>th</sup>. We will need to re-stock the shelves to get the store open. We should be opening no later than January 22<sup>nd</sup>. We received \$100,000 from the insurance company and they covered the wages for the employees while they were off work. They used to use Verde Fire and Safety and they are certified for the fire extinguishers only. Distant Drums and Whitehills may switch to B&W also.

There was a consensus from the Council to move to B&W for the fire protection for Market Place and to purchase the sprinkler system. This will be paid out of the Market Place Budget.
