RESOLUTION NO. 162 - 21 OF THE GOVERNING BODY OF THE YAVAPAI-APACHE NATION

A Resolution Approving the Purchase of Four Transit Buses with Funding from the Federal Transit Administration Grant Award #AZ-2021-016-00

- WHEREAS: The Yavapai-Apache Nation Tribal Council ("Council") is authorized to represent the Yavapai-Apache Nation ("Nation") and act on all matters that concern the health and welfare of the Nation, and to make decisions not inconsistent with or contrary to the Constitution of the Yavapai-Apache Nation ("Constitution") as provided under Article V(a) of the Constitution; and
- WHEREAS: The Council is authorized to negotiate and enter into agreements with federal, state and local governments and to accept grant funds as provided under Article V (b) and (s), respectively, of the Constitution; and
- WHEREAS: The Council is authorized to manage all tribal economic affairs and to appropriate and regulate the use of the Nation's funds as provided under Article V (i) and (k), respectively, of the Constitution; and
- WHEREAS: The Nation applied for and was awarded a grant from the Federal Transit Administration, Award #AZ-2021-016-00, for the operation and expansion of the Nation's Transit System; and
- WHEREAS: The Nation's Public Works Manager recommends purchasing four transit buses from Creative Bus Sales with funding from the grant at a price not to exceed Three Hundred Ninety-Five Thousand Five Hundred Thirty-Six and 00/100 Dollars (\$395,536.00) as set forth on the Buyer's Order of Contract (attached to this Resolution as Exhibit A and incorporated herein by reference), as authorized under the grant; and
- WHEREAS: The purchase of the four transit buses will allow for the Nation's Transit System to expand its routes to Prescott and Phoenix; and
- **WHEREAS:** The Tribal Council finds it in the best interest of the Nation to approve the purchase of the four transit buses with funding from the Federal Transit Administration Grant Award #AZ-2021-016-00.

NOW THEREFORE BE IT RESOLVED that the Yavapai-Apache Nation Tribal Council, in Council assembled, at which a quorum is present, hereby authorizes the Nation to purchase four transit buses from Creative Bus Sales at a price not to exceed Three Hundred Ninety-Five Thousand Five Hundred Thirty-Six and 00/100 Dollars (\$395,536.00) as set forth on the Buyer's Order of Contract (attached to this Resolution as Exhibit A) with funding from the Federal Transit Administration Grant Award #AZ-2021-016-00.

BE IT FINALLY RESOLVED that the Chairman and Vice-Chairwoman, or either of them, are hereby authorized to take such further action as deemed necessary to carry out the intent and purposes of this Resolution.
