RESOLUTION NO. ______-2022 OF THE GOVERNING BODY OF THE YAVAPAI-APACHE NATION

A Resolution Approving an Amendment and Funding Allocation Increase under the Nation's Older Americans Act Title III Grant Award from the Inter Tribal Council of Arizona in Support of the Nation's Senior Program

- WHEREAS: The Yavapai-Apache Nation Tribal Council ("Council") is authorized to represent the Yavapai-Apache Nation ("Nation") and act on all matters that concern the health and welfare of the Nation, and to make decisions not inconsistent with or contrary to the Constitution of the Yavapai-Apache Nation ("Constitution") as provided by Article V (a) of the Constitution; and
- WHEREAS: The Council is authorized to manage all tribal economic affairs and enterprises of the Nation and to appropriate and regulate the use of tribal funds, as provided by Article V (i) and (k), respectively, of the Constitution;
- WHEREAS: The Council is authorized to negotiate with Federal, State and local governments and to accept grants and donations from any person, organization, state, or the United States as provided by Article V (b) and (s), respectively, of the Constitution; and
- WHEREAS: The Council, as the legislative body of the Nation, is authorized to enact laws, ordinances, and resolutions incidental to the exercise of its legislative powers as provided by Article V(v) of the Constitution; and
- WHEREAS: The Nation currently provides various services for the benefit of its community members under Federal programs administered by the Inter Tribal Council of Arizona, Inc. (ITCA) through agreements with the Nation, including under Title III of the Older Americans Act (OAA); and
- WHEREAS: ITCA has provided the Nation a "FY2022 Title III Notification of Grant Award Amendment No. 01" (Notification) under which ITCA will allocate to the Nation additional funds in the amount of \$46,500.00 in support of the Nation's Title III OAA Program, said funds originating under the Consolidated Appropriations Act (CAA) and the American Rescue Plan Act (ARPA), which funds are allocated to provide additional resources to the Senior Program to support the services provided in accordance with the Notification attached to this Resolution as Exhibit A; and
- WHEREAS: Under the Notification the Nation will receive additional funds in the amount of Forty-Six Thousand Five Hundred Dollars (46,500) for a revised Title III OAA budget of One Hundred Three Thousand Three Hundred Nine Dollars (\$103,309.00); and
- WHEREAS: Under the Notification ITCA also approves the Senior Program's request to purchase a new vehicle, two (2) reach-in refrigerators, an ice machine, and a water heater; and

WHEREAS: The Council finds it in the Nation's best interest to approve the attached Notification of Grant Award, Amendment No. 01, under the Grant Agreement between the Nation and ITCA for the Title III Older Americans Act Program, for the benefit of the Nation's senior members.

NOW THEREFORE BE IT RESOLVED that the Yavapai-Apache Nation Tribal Council, in Council assembled, at which a quorum is present, hereby approves the attached Notification of Grant Award, Amendment No. 01, under the Grant Agreement between the Nation and ITCA in accordance with its Terms and Conditions, a copy of which Notification is attached hereto as **Exhibit A** and incorporated into this Resolution by reference.

BE IT FURTHER RESOLVED that the Senior Program is authorized to purchase, in accordance with the Nation's Procurement Code, the items authorized for purchase by ITCA under the Notification, including a new vehicle, two (2) reach-in refrigerators, an ice machine, and a water heater.

BE IT FINALLY RESOLVED that the Chairman, and Vice-Chairwoman, or either of them, are hereby authorized to take such further action as deemed necessary to carry out the intent and purposes of this Resolution.
