# RESOLUTION NO. 39 - 2022 OF THE GOVERNING BODY OF THE YAVAPAI-APACHE NATION

# A Resolution Authorizing the Nation to Submit a Grant Application to the Arizona Commission on the Arts, Flinn Foundation Mini-Grant, for use in supporting Yavapai and Apache Art

- WHEREAS: The Yavapai-Apache Tribal Council ("Council") is authorized to represent the Yavapai-Apache Nation ("Nation") and act on all matters that concern the health and welfare of the Nation, and to make decisions not inconsistent with or contrary to the Constitution of the Yavapai-Apache Nation ("Constitution") as provided under Article V(a) of the Constitution; and
- WHEREAS: The Council is authorized to negotiate and enter into agreements with federal, state, and local governments and to accept grant funds as provided under Article V (b) and (s), respectively, of the Constitution; and
- WHEREAS: The Council is authorized to manage all tribal economic affairs and to appropriate and regulate the use of the Nation's funds as provided under Article V (i) and (k), respectively, of the Constitution; and
- WHEREAS: The Nation's Contracts and Grants Manager recommends that the Nation apply for grant funding as follows:
  - (1) Funding Agency: Arizona Commission on the Arts, Flinn Foundation Mini-Grant
  - (2) Amount of funding application: \$5,000
  - (3) Term of grant: 1 year
  - (4) Matching funds and source: None
  - (5) Nation's Department or Program administering the grant: Cultural Department Offices of Apache Culture, Yavapai Culture and Preservation and Technology
  - (6) Purpose and use of grant funds: Reinvigorate and promote traditional Yavapai and Apache art for the Nation
  - (7) Budget attached or not required: Attached; and
- **WHEREAS:** The Tribal Council finds it in the Nation's best interest to authorize the above-described grant application.

**NOW THEREFORE BE IT RESOLVED** that the Yavapai-Apache Tribal Council, in Council assembled, at which a quorum is present, hereby authorizes the Nation to apply for grant funding to the above-named funding agency in the amount and for the term described above.

**BE IT FURTHER RESOLVED** that the Nation agrees that it will comply with all program guidelines and regulations applicable to the above referenced grant program and the certifications required in the grant application.

**BE IT FURTHER RESOLVED** that the Council authorizes the Nation's Contracts and Grants Manager to take all actions necessary to complete the grant application and to submit all necessary information to the funding agency in furtherance of the authorized grant application and authorizes the Nation to receive and expend the grant funds in accordance with the grant requirements and the Nation's Budget Code and Financial Policies.

**BE IT FINALLY RESOLVED** that the Chairman and Vice-Chairwoman, or either of them, are hereby authorized to take such further action as deemed necessary to carry out the intent and purposes of this Resolution.

1. With the goal of preserving the culture and art of the Yavapai and Apache People, the Yavapai-Apache Nation's Culture Department continues to support and advance Yavapai and Apache art. Funding from the Flinn Foundation will allow current programs to expand to serve additional participants. Though activities were slowed down during the COVID-19 pandemic; with the Yavapai-Apache Nation now working at near full capacity artist and related activities can again be presented to members of the Nation and other interested parties.

Focus will be on traditional art such as dress making, beading, gourd creative art and drums, pottery, traditional dance, metal sculpture and other relevant art related activities.

For the upcoming year the focus will be on notifying past participants, recruiting new members and reestablishing art workshops with regular schedules.

Special effort will be made throughout the year and into the future to introduce and maintain traditional art for the youth and young adults. It is important that these groups understand the need to preserve traditional art as it will always be part of their heritage and culture.

2. Funds will be used as follows:

\$2,000 for art supplies

\$2,500 as stipend for Elders, traditional artist, and other experts in Yavapai & Apache art for instructing, displaying, and sharing historical knowledge on art and culture

\$400 for staff travel to view and record art artifacts of historical significance

\$100 for general office supplies

\$5,000 Total
