RESOLUTION NO. \23 -22 OF THE GOVERNING BODY OF THE YAVAPAI-APACHE NATION

A Resolution Authorizing the Nation to Purchase a Truck for the Wildland Fire Department

- WHEREAS: The Yavapai-Apache Tribal Council ("Council") is authorized to represent the Yavapai-Apache Nation ("Nation") and act on all matters that concern the health and welfare of the Nation, and to make decisions not inconsistent with or contrary to the Constitution of the Yavapai-Apache Nation ("Constitution") as provided under Article V(a) of the Constitution; and
- WHEREAS: The Council is authorized to "appropriate and regulate the use of tribal funds" as provided under Article V (k) of the Constitution; and
- WHEREAS: The Nation's Wildland Fire Department ("Department") is responsible for wildland fire management activities on the Nation's lands which is an essential part of the Nation's governmental operations; and
- WHEREAS: The Wildland Fire Manager has identified the need to acquire a truck for use in wildland fire management activities; and
- WHEREAS: Following the solicitation of quotes, the Wildland Fire Manager recommends the Nation purchase a 2022 Chevrolet Silverado 2500HD truck from Larry Green Chevrolet in accordance with the terms and conditions of the Order attached to this Resolution as Exhibit A and incorporated herein by reference for the purchase price of \$68,671.50; and
- WHEREAS: Funding to purchase the truck is available from the ARPA Aid to Tribal Government funds received by the Nation; and
- WHEREAS: The Council has determined that it is in the best interest of the Nation to purchase the truck from Larry Green Chevrolet in accordance with the terms and conditions of the Order attached hereto as Exhibit A.

NOW THEREFORE BE IT RESOLVED that the Yavapai-Apache Tribal Council, in Council assembled, at which a quorum is present, hereby authorizes the Nation to purchase the 2022 Chevrolet Silverado 2500HD truck from Larry Green Chevrolet in accordance with the terms and conditions of the Order attached to this Resolution as Exhibit A for the purchase price of \$68,671.50.

BE IT FURTHER RESOLVED that the ARPA Aid to Tribal Government funds shall be used to pay the purchase price as provided in the amended BIA ARPA Aid to Tribal Government Funds Budget.

BE IT FINALLY RESOLVED that the Chairman, and Vice-Chairwoman, or either of them, are hereby authorized to take such further action as deemed necessary to carry out the intent and purposes of this Resolution.
