HISTORIC TRIBAL LAND ACQUISITION AGREEMENT



After several years of dedicated negotiations, the Town of Camp Verde, Arizona and the Yavapai-Apache Nation have reached a historic agreement to support the return of a small part of the Nation's ancestral lands located within the municipal boundaries of the Town of Camp Verde to the Nation.

Under the terms of the Agreement approved on June 16, 2022 by the governing councils for both the Town

and the Nation, U.S. Forest Service lands identified in the Agreement – if successfully exchanged with the Forest Service in the future – can be added to the Nation's existing reservation with the full support of the Town. The Agreement also cements the Nation's support for the Town's potential acquisition of up to 40 acres of land along General Crook Road to develop new public safety facilities to improve emergency response times.

"This Agreement reflects years of work by the Yavapai-Apache Nation and the Town of Camp Verde," says Jon Huey, Chairman of the Yavapai-Apache Nation. "Most of these lands in this Agreement were once part of our original reservation that was established in 1871 by President Grant," says Huey. "Having the opportunity to see a small part of these lands returned to us, and with the full cooperation of the Town of Camp Verde, is an amazing opportunity for the Nation, the Town, and the entire region."

Under the Agreement, the Town would receive retail sales tax revenue generated from future non-tribal developments on the lands added to the Nation's reservation. The Agreement also designates approximately 1,200 acres of Forest Service lands located at the intersection of Interstated-17 and the 260 Highway as the "Yavapai-Apache - Camp Verde Economic Development Corridor" for commercial development purposes, with the Nation agreeing to collect and pay 1% in retail sales to the Town from the Nation's future commercial developments in the corridor.

The Agreement also formalizes a process for continued cooperation between the Nation and Town on future development projects and makes clear that existing roads, utility, and other easements will be maintained on any lands added to the Nation's reservation to preserve historic access in the region.

- 60-20 Declaring a State of Emergency Due to the Coronavirus (COVID-19) Outbreak Authorizes the Executive Offices of the Chairman and Vice-Chairwoman (the "Executive") to coordinate emergency and disaster relief and seek assistance from federal, state, other tribal governments, and local and private agencies to address the public health emergency created by the Coronavirus.
- 95-20 Approving a Reopening of the Cliff Castle Casino and Hotel Under a Reopening Operations Plan and Requiring Implementation of Ongoing Coronavirus (COVID-19) Public Safety Measures
 Approval to re-open Cliff Castle Casino Hotel on June 1, 2020 at 10am with safety measures implemented.
- Adopting the revised Yavapai-Apache Nation COVID-19 Workplace Safety Policy, the Yavapai-Apache Nation Subordinate Economic Organization (SEO) COVID-19 Workplace Safety Plan, and the Yavapai-Apache Nation COVID-19 Safety Policy for Committees, Commissions, and Boards Reduce face-to-face business where feasible. Employees who are not full vaccinated must wear a mask when they are within 6 feet of other persons, unless there is a plexiglass parition between the employee and other persons. Employees must also ask their clients, vendors, and customers who are not fully vaccinated to wear a mask if they are within 6 feet of other persons.
- 98-21 Rescinding Tribal Council Resolutions Nos. 70-20, 84-20, and 214-20 The stay-at-home order, closure of the Yavapai-Apache Nation Reservation Lands, and the curfew are lifted, as well as the restrictions on social events within the Nation's Lands. The YAN COVID-19 Workplace Safety Policy, the YAN COVID-19 Safety Policy for Committees, Commissions, and Boards, and the YAN Subordinate Economic Organization Workplace Safety Policy remain in effect.
- 141-21 Revisions to the Yavapai-Apache Nation COVID-19 Workplace Safety Policy, Subordinate Economic Organization (SEO) COVID-19 Workplace Safety Policy, and COVID-19 Safety Policy for Tribal Council, Committees, Commissions, and Boards The Tribal Council has reviewed and approved revisions to the above policies effective immediately except the COVID-19 testing requirement in the Yavapai-Apache Nation COVID-19 Workplace Safety Policy which is effective August 30, 2021.
- 207-21 Amendments to the COVID-19 Emergency Rental Assistance Program Policy The COVID-19 Emergency Rental Assistance Program Policy now reflects Treasury guidance on the allowable uses of the assistance and documentation requirements to verify eligibility for assistance.
