CHAIR VOLLEYBALL RULES

- Teams of 6 players must include one youth player (7-18 years) one golden player (55 years and older).
 - If you need assistance finding a player please contact Monica 928-202-8638
1. Teams of 6 players, pick your Team Captain. You must remain on same team you start with.
 2. Court size is 10ft. Wide, 20 ft. Long and 6ft. High.
 3. A coin toss will determine which team will serve the ball to start the game.
 4. Servers must wait for the referees whistle before each serve.
 5. No blocking the serve.
 6. 3 HIT LIMIT! Players can hit off the net within 3 hit limit.
 7. No hanging or pulling on the net and only spiking from back row allowed.
 8. If the ball lands on any part of the boundary line it is considered in bounds.
 9. All players must stay seated on chair at all times.
 10. The first team to 15 points wins the game, 2 out of 3 format will be played to determine the winner.
 11. 20 minute time limit for each game. After the time limit is reached, next point wins if the score is tied.
 12. If the ball hits the bottom bar it is considered dead ball. You may still continue to play off the side bars.

13. Legal hits: Any contact with the ball by a player's body, above and including the knees not allowing the ball to visibly come to rest. No kicking the ball.
14. If the chair legs come off the ground the play is ended,
15. Any call in question by the team can be communicated to the referee by the team Captain ONLY.

Voluntary Waiver of Liability, Assumption of Risk and Indemnity Agreement

Waiver: In consideration of my being permitted to participate in the Chair Volleyball Tournament, hereinafter the "Activity", I, for myself, my heirs, personal representatives and assigns, do hereby release, waive, discharge, and covenant not to sue the Yavapai-Apache Nation, their officers, employee's agents and volunteers (singularly and collectively referred to herein as "YAN, from all liability and from any and all claims, including but not limited to claims arising out of the negligence of YAN, resulting in personal injury, accidents or illnesses (including death), and property loss arising from, but not limited to, my participation in the Activity.

Assumption of Risks: I understand that my participation in the Activity carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. Those risks include, but are not limited to, falling from chair, being hit with the ball or by other participants reaching for the ball, and all other risks inherent to the activity of chair volleyball. The risks and dangers include but not limited to head injury, neck, back or hip injury, wrist fractures, and other orthopedic injuries to limbs and joints. Knowing, understanding, and fully appreciating all possible risks associated with my participation in the Activity, I hereby expressly, voluntarily, and willingly assume all risks and dangers associated with my participation in the Activity.

I have read the previous paragraph's and I know, understand, and appreciate these and other risks that are inherent in the Activity. I hereby assert that my participation in the Activity is voluntary and that I knowingly assume all risks inherent in the Activity.

Indemnification and Hold Harmless: In accordance with and in furtherance of the Waiver and Assumption of Risk as provided hereinabove, I also agree to indemnify and hold YAN harmless from any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities, including attorney's fees brought by me or any other party as a result of my participation in the Activity and do hereby agree to reimburse YAN for any such costs, expenses, damages, liabilities and fees incurred.

Severability: The undersigned further expressly agrees that the foregoing waiver and assumption of risks agreement is intended to be broad and inclusive as is permitted by the

laws of the Yavapai-Apache Nation and the laws of the State of Arizona, to the extent that said laws of Arizona are applied by the Nation, and that if any portion of this Agreement is held invalid, it is agreed that the balance shall, notwithstanding such invalidity, continue in full legal force and effect.

Acknowledgement of Understanding: I have read this Waiver of Liability, Assumption of Risk, and Indemnify agreement, fully understand its terms, and understand that I am giving up substantial rights, including my right to sue YAN, if any, all in exchange for my being permitted to participate in the Activity. I acknowledge that I am signing the agreement freely and voluntarily, and intend for this agreement, as evidence by my signature, to be a complete and unconditional release of all liability of YAN arising out of my participation in the Activity to the greatest extent allowed by the law.
