

RESOLUTION NO. 178-22  
OF THE GOVERNING BODY OF THE  
YAVAPAI-APACHE NATION

**A Resolution Authorizing the Nation to Purchase a New Grain Auger from BP AG Systems, for use by the Nation's Agricultural Resource Department under the Nation's Cloverleaf Farm and Ranch Operations**

- WHEREAS:** The Yavapai-Apache Nation Tribal Council ("Council") is authorized to represent the Yavapai-Apache Nation ("Nation") and act on all matters that concern the health and welfare of the Nation, and to make decisions not inconsistent with or contrary to the Constitution of the Yavapai-Apache Nation ("Constitution") as provided for under Article V(a) of the Constitution; and
- WHEREAS:** The Council is authorized to "appropriate and regulate the use of tribal funds" as provided by Article V (k) of the Constitution; and
- WHEREAS:** The Nation's Department of Agricultural Resources has advised the Council of the need to purchase a grain auger for use in handling grain as part of the Nation's Cloverleaf Farm and Ranch operations; and
- WHEREAS:** After soliciting prices from several sources, the Department has identified a new 10' X 73' Hutchinson Auger, for sale by BP AG Systems ("BP AG"), and the Department seeks the Council's authorization to purchase the auger in accordance with the terms and conditions of the invoice attached hereto as **Exhibit A** (BP AG Invoice # A22002), under which the Nation will purchase the auger from BP AG for a total **purchase price of \$20,008.73**, inclusive of shipping cost to the Nation; and
- WHEREAS:** The Council has determined that approval of the purchase of the auger from BP AG is in the best interest of the Nation.

**NOW THEREFORE BE IT RESOLVED** that the Yavapai-Apache Tribal Council, in Council assembled, at which a quorum is present, hereby authorizes the Yavapai-Apache Nation to purchase the above-described auger from BP AG Systems, in accordance with the terms set out in the invoice attached to this resolution as **Exhibit A** (BP AG Invoice # A22002), for a **total purchase price of \$20,008.73**.

**BE IT FURTHER RESOLVED** that funds for payment of the purchase price are hereby appropriated and shall be paid from the Agricultural Resources Department's FY2022 Budget, Equipment Line Item, in the amount of **\$20,008.73**.


**BE IT FINALLY RESOLVED** that the Vice-Chairwoman is hereby authorized to take such further action as deemed necessary to carry out the intent and purposes of this Resolution.

**CERTIFICATION**

Per the Nation's Procurement Code, the Agricultural Resources Dept. solicited for three quotes. Below is a list of all quotes.



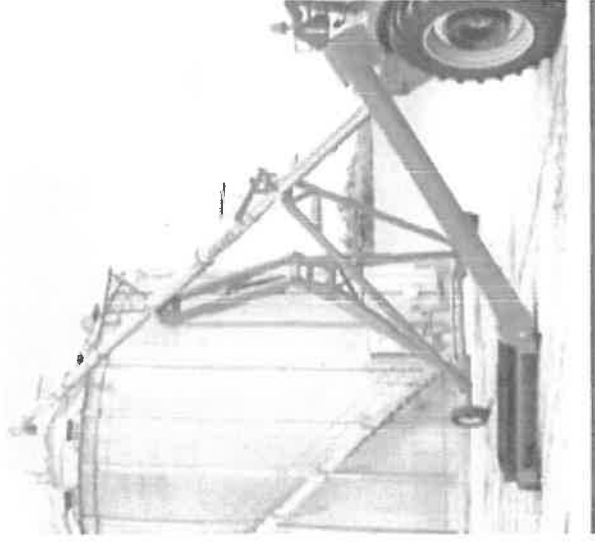
