

A Resolution Authorizing the Purchase of Police Vehicles and Related Equipment

- WHEREAS: The Yavapai-Apache Tribal Council ("Council") is authorized to represent the Yavapai-Apache Nation ("Nation") and to act on all matters that concern the health and welfare of the Nation, and to make decisions not inconsistent with or contrary to the Constitution of the Yavapai-Apache Nation ("Constitution") as provided under Article V(a) of the Constitution; and
- WHEREAS: The Council is authorized to negotiate and enter into agreements with federal, state and local governments and to accept grant funds as provided under Article V (b) and (s), respectively, of the Constitution; and
- WHEREAS: The Council is authorized to manage the economic affairs of the Nation and to appropriate and regulate the use of the Nation's funds as provided under Article V (i) and (k), respectively, of the Constitution; and
- **WHEREAS:** On March 19, 2020, the Council adopted Council Resolution No. 60-20 declaring a State of Emergency due to the COVID-19 public health emergency; and
- WHEREAS: On March 11, 2021, the American Rescue Plan Act ("ARPA") was signed into law, establishing the Coronavirus State and Local Fiscal Recovery Funds ("ARPA Recovery Funds") and setting aside \$20 billion in aid for Tribal governments to respond to the impact of the continuing COVID-19 public health emergency; and
- WHEREAS: On January 27, 2022, the U.S. Department of Treasury published a Final Rule under ARPA providing further descriptions and examples of how ARPA Recovery Funds may be used by recipients; and
- WHEREAS: The Final Rule provides that ARPA Recovery Funds may be used by recipients to respond to the public health emergency, including preventing and responding to increased violence resulting from the public health emergency, including enforcement efforts to reduce violence and investing in technology and equipment;
- **WHEREAS:** The Final Rule also provide that ARPA Recovery Funds may be used by recipients for expenditures to improve public safety for disproportionately impacted communities; and
- WHEREAS: The Nation's Police Chief has identified a need to purchase police vehicles to replace worn vehicles used in the response to the public health emergency and to continue to be in a position to respond to the public health emergency and provide other law enforcement services, and recommends the purchase of the following police vehicles and related equipment:

- 1. Eight (8) 2023 Chevrolet Tahoe 4WD vehicles from Daniels Long Chevrolet for the price of \$44,512.00 each (*Quote attached to this Resolution as Exhibit A and incorporated herein by reference*), for a total cost of \$356,096.00; and
- 2. Outfitting for each of the eight (8) vehicles from Arizona Emergency Products for the price of \$22,117.94 each (Quote attached to this Resolution as Exhibit B and incorporated herein by reference), for a total cost of \$176,943.52; and
- 3. Six (6) police radios from Motorola Solutions, Inc. for the total cost of \$15,459.78 (Invoice attached to this Resolution as Exhibit C and incorporated herein by reference); and

WHEREAS: Funding to purchase the police vehicles and related equipment is available to be paid from the ARPA Recovery Funds received by the Nation; and

WHEREAS: The Council finds it is in the best interest of the Nation to purchase the police vehicles and related equipment as described above for the Nation's Police Department.

NOW THEREFORE BE IT RESOLVED that the Yavapai-Apache Tribal Council, in Council assembled, at which a quorum is present, hereby authorizes the Nation to purchase the police vehicles and related equipment listed above and as further described in Exhibits A-C for the grant total cost of \$548,499.30.

BE IT FURTHER RESOLVED that the Nation's funds shall be used to pay the purchase price and said funds shall be appropriated from the ARPA Recovery Funds received by the Nation.

BE IT FURTHER RESOLVED that Council Resolution No. 178-21 and Council Resolution No. 130-22 authorizing the lease of police vehicles from Enterprise Fleet Management are rescinded as those vehicles have not become available.

BE IT FINALLY RESOLVED that the Chairwoman, and Vice-Chairman, or either of them, are hereby authorized to take such further action as deemed necessary to carry out the intent and purposes of this Resolution.
