- WHEREAS: The Yavapai-Apache Nation Tribal Council ("Council") is authorized to represent the Yavapai-Apache Nation ("Nation") and act on all matters that concern the health and welfare of the Nation, and to make decisions not inconsistent with or contrary to the Constitution of the Yavapai-Apache Nation ("Constitution") as provided by Article V (a) of the Constitution; and
- WHEREAS: The Council, as the legislative body of the Nation, is authorized to enact laws, ordinances and resolutions incidental to the exercise of its legislative powers as provided by Article V(v) of the Constitution; and
- WHEREAS: The Council is authorized to negotiate with other governments, manage the economic affairs of the Nation, and appropriate and regulate the use of the Nations funds, all as provided under Article V(b), (i) and (k), respectively, of the Constitution; and
- WHEREAS: The Nation administers the United States Department of Labor's Workforce Innovation and Opportunity Act ("WIOA") Program under a Memorandum of Agreement ("MOA") with the Inter Tribal Council of Arizona ("ITCA"), as authorized under of the Workforce Investment Act of 1998 ("WIA"), Section 166, Native American Programs (Adult and Youth Programs); and
- WHEREAS: ITCA has notified the Nation that the Nation's WIOA Program MOA with ITCA for Program Year ("PY") 2021 (2021-2023) is amended to increase the WIOA Section 166 Title I-D Adult Comprehensive Service Plan and the Supplemental Youth Services Plan fund budgets, as reflected in Amendment No. 1 to the MOA attached to this resolution as Exhibit A; and
- **WHEREAS:** The amended term and budget under the MOA is as follows:
 - 1. Adult Program July 1, 2021 to June 30, 2023 Amended Total Budget: \$18,533.00
 - 2. Youth Program April 1, 2021 to June 30, 2023 Amended Total Budget: \$9,972.00

Combined Total PY 2021 Budget: \$28,505.00
