# RESOLUTION NO. 2-VS -22 OF THE GOVERNING BODY OF THE YAVAPAI-APACHE NATION

## A Resolution Approving Amendment No. 1 to the Special Counsel Attorney Contract between the Yavapai-Apache Nation and the Law Firm of Ellis George Cipollone, LLP

- WHEREAS: The Yavapai-Apache Tribal Council ("Council") is authorized to represent the Yavapai-Apache Nation ("Nation") and to act on all matters that concern the health and welfare of the Nation, and to make decisions not inconsistent with or contrary to the Constitution of the Yavapai-Apache Nation (Constitution), as provided by Article V(a) of the Constitution; and
- WHEREAS: The Council is authorized to manage all tribal economic affairs and to appropriate tribal funds as provided under Article V(i) and (k), respectively, of the Constitution; and
- **WHEREAS:** The Council is authorized to employ legal counsel as provided by Article V(c) of the Constitution; and
- WHEREAS: The Yavapai-Apache Nation Budget and Appropriations Code, adopted by Resolution No. 55-19 on April 2, 2019, and amended by Resolution No. 195-20 on December 10, 2020, provides that a budget amendment shall be approved by Tribal Council resolution for additional appropriations, as set forth in Section 303 of the Code; and
- WHEREAS: Under Council Resolution No. 260-21, adopted December 16, 2021, the Council approved a Special Counsel Attorney Contract ("Contract") between the Nation and the law firm of Browne George Ross, LLP ("BGR") to provide legal representation in certain litigation and related matters arising out of the Nation's past business relationships with the Santa Ysabel Band of Diegueno Mission Indians ("Santa Ysabel") and the LaPosta Band of Diegueno Mission Indians ("LaPosta"); and
- WHEREAS: When Resolution No. 260-21 was adopted, Firm was organized under the law firm name of Browne George Ross O'Brien Annaguey & Ellis, LLP, and has since reorganized as Ellis George Cipollone O'Brien Annaguey, LLP (Ellis George Cipollone or EGC) and the Council wishes to update the Contract with Firm to reflect the Firm's new name; and
- **WHEREAS**, Resolution No. 260-21 set a "Cap on Total Compensation" to be paid under the Contract at \$110,000.00; and
- WHEREAS: Work under the Contract has proceeded as directed by the Tribal Council, however the scope of the work has intensified, and the costs of the work has exceeded the Nation's and ECG's original FY2022 Budget estimate of One Hundred Ten Thousand Dollars (\$110,000.00) for legal fees and costs in the matter of the Nation's litigation against Santa Ysabel and LaPosta; and

WHEREAS: An Amendment No. 1 to the Contract (attached to this Resolution as Exhibit A) is needed to appropriate and provide for the expenditure of additional funds under the Contract in the amount of One Hundred Sixteen Thousand Dollars (\$116,000.00) – the additional funding needed to cover the costs of providing representation to the Nation in the LaPosta and Santa Ysabel litigation as accrued through October 31, 2022 and for the remainder of FY2022- for a total capped Contract amount under the Contract not to exceed Two Hundred Twenty-Six

Thousand Dollars (\$226,000.00) for FY2022; and

WHEREAS: The Council has discussed this matter with the Nation's Attorney General and the Treasurer and has determined that the additional fees and expenses arising under the Ellis George Cipollone, LLP Contract, as approved under this Resolution, shall be paid out of the Nation's general funds appropriated by the Council hereunder to the Attorney General's Budget for payment of Attorney's fees; and

WHEREAS: The Council has reviewed Amendment No. 1 to the Special Counsel Attorney Contract with Ellis George Cipollone, LLP (attached to this Resolution as Exhibit A) and deems it to be in the Nation's best interest to approve Amendment No. 1 to the Special Counsel Attorney Contract according to the terms stated therein.

NOW THEREFORE BE IT RESOLVED that the Yavapai-Apache Tribal Council, in Council assembled, at which a quorum is present, hereby approves Amendment No. 1 to the Nation's Special Counsel Attorney Contract with the law firm of Ellis George Cipollone, LLP (attached to this Resolution as Exhibit A and incorporated herein by reference) to raise the Cap on Total Compensation under the Contract and to approve additional contract funding in the amount of One Hundred Sixteen Thousand Dollars (\$116,000.00) for an amended Cap on Total Compensation in an amount not to exceed Two Hundred Twenty-Six Thousand Dollars (\$226,000.00) for FY2022, said additional funds to be used to pay the additional and unanticipated legal fees and costs (as explained hereinabove) arising under the Contract during FY2022.

**BE IT FURTHER RESOLVED** that the Council hereby appropriates the amount of One Hundred Sixteen Thousand Dollars (\$116,000.00) from the General Fund and directs the Nation's Treasurer to add said funds to the Attorney General's FY2022 Budget, General Ledger Account #7210 ("Attorney's Fees Expense"), in order to fund the additional contract funding authorized by this Resolution for payment of the above referenced fees and costs under the Ellis George Cipollone, LLP Contract for FY2022.

**BE IT FURTHER RESOLVED** that the FY2022 Budget of the Office of Attorney General is hereby amended to reflect the above-additional appropriation of funds to the Attorney General's FY2022 Budget.

**BE IT FINALLY RESOLVED** that the Chairwoman, and Vice-Chairman, or either of them, are hereby authorized to take such further action as deemed necessary to carry out the intent and purposes of this Resolution.

## AMENDMENT NO. 1 TO THE SPECIAL COUNSEL ATTORNEY CONTRACT BETWEEN THE YAVAPAI-APACHE NATION AND ELLIS GEORGE CIPOLLONE, LLP

This AMENDMENT ("Amendment") is dated and made effective as of the 16th day of November 2022 (the "Effective Date") by and between the YAVAPAI-APACHE NATION ("Nation") and the Law Firm of ELLIS GEORGE CIPOLLONE, LLP ("Firm").

#### RECITALS

WHEREAS, under authority of Tribal Council Resolution No. 260-21, adopted December 16, 2021 the Nation and Firm entered into a Special Counsel Attorney Contract ("Contract") for legal services in the matter of certain litigation arising out of the Nation's past business relationships with the Santa Ysabel Band of Diegueno Mission Indians and the LaPosta Band of Diegueno Mission Indians, and for such other work as requested by the Nation acting through its Tribal Council and/or the Nation's Office of Attorney General; and

WHEREAS, When Resolution No. 260-21 was adopted, Firm was organized under the law firm name of Browne George Ross O'Brien Annaguey & Ellis, LLP, and has since reorganized as Ellis George Cipollone O'Brien Annaguey, LLP (Ellis George Cipollone) and the Council wishes to update the Contract with Firm to reflect the law firm's new name; and

WHEREAS, Resolution No. 260-21 set a "Cap on Total Compensation" to be paid under the Contract at \$110,000.00 and the required amount of work and compensation under the abovereferenced litigation has intensified and exceeded the Cap; and

WHEREAS, Nation and Attorney wish to enter into this Amendment in order to amend the Cap on Compensation by adding One Hundred Sixteen Thousand Dollars (\$116,000.00), as set forth below.

**NOW THEREFORE**, in consideration of the foregoing recitals and the mutual covenants set out herein, the Nation and Firm agree to amend the Contract as follows:

Contract:

The Contract with Firm is amended to reflect that Firm is now organized under the law firm name of Ellis George Cipollone O'Brien Annaguey, LLP (Ellis George Cipollone)

Section 4:

"Cap on Contract Total compensation to Browne George Ross LLP under this agreement for the Term of the Agreement (FY2022) shall **not exceed Two Hundred Twenty-Six Thousand and 00/100 Dollars (\$226,000.00)**, unless expressly agreed to by the Nation's Tribal Council as set forth in a Resolution of the Council"

All other terms and conditions of said Contract, not expressly amended herein, shall remain unchanged and in full force and effect.
