RESOLUTION NO. 218 -22 OF THE GOVERNING BODY OF THE YAVAPAI-APACHE NATION

A Resolution Authorizing the Nation to Purchase Furniture for the Tribal Council Chambers and Lobby

- WHEREAS: The Yavapai-Apache Tribal Council ("Council") is authorized to represent the Yavapai-Apache Nation ("Nation") and act on all matters that concern the health and welfare of the Nation, and to make decisions not inconsistent with or contrary to the Constitution of the Yavapai-Apache Nation ("Constitution") as provided under Article V(a) of the Constitution; and
- **WHEREAS:** The Council is authorized to "appropriate and regulate the use of tribal funds" as provided under Article V (k) of the Constitution; and
- WHEREAS: The Executive Office has identified the need to replace the furniture in the Tribal Council Chambers and the lobby within the Nation's Administration Building; and
- WHEREAS: The Executive Office recommends the Nation purchase the following furniture from Arizona Office Liquidators & Designs for a total purchase price of \$14,163.60:
 - Fifteen (15) executive chairs as descripted in Proposal 46225 attached to this Resolution as Exhibit A and incorporated herein by reference for the purchase price of \$6,749.25; and
 - Various chairs, tables, and loveseat as described in Proposal 46226 attached to this Resolution as Exhibit B and incorporated herein by reference for the purchase price (including installation and delivery) of \$7,414.35; and
- **WHEREAS:** Funding to purchase the furniture is available from the Finance Indirect Cost funds; and
- **WHEREAS:** The Council has determined that it is in the best interest of the Nation to purchase the furniture for the Tribal Council Chambers and lobby within the Nation's Administration Building.

NOW THEREFORE BE IT RESOLVED that the Yavapai-Apache Tribal Council, in Council assembled, at which a quorum is present, hereby authorizes the Nation to purchase the above-described furniture for the Tribal Council Chambers and lobby within the Nation's Administration Building from Arizona Office Liquidators & Designs for a total purchase price of \$14,163.60.

BE IT FURTHER RESOLVED that the Finance Indirect Cost funds shall be used to pay the purchase price.

BE IT FINALLY RESOLVED that the Chairwoman and Vice-Chairman, or either of them, are hereby authorized to take such further action as deemed necessary to carry out the intent and purposes of this Resolution.


