RESOLUTION NO. 229 -22 OF THE GOVERNING BODY OF THE YAVAPAI-APACHE NATION

A Resolution Authorizing the Nation to Purchase a Crack Sealer for the Public Works Department

- WHEREAS: The Yavapai-Apache Tribal Council ("Council") is authorized to represent the Yavapai-Apache Nation ("Nation") and act on all matters that concern the health and welfare of the Nation, and to make decisions not inconsistent with or contrary to the Constitution of the Yavapai-Apache Nation ("Constitution") as provided under Article V(a) of the Constitution; and
- WHEREAS: The Council is authorized to "appropriate and regulate the use of tribal funds" as provided under Article V (k) of the Constitution; and
- **WHEREAS:** The Public Works Manager has identified the need to purchase a crack sealer for road maintenance purposes; and
- WHEREAS: Following the receipt of quotes, the Public Works Manager recommends the Nation purchase a crack sealer from Crafco Inc. as described in Quote #BBBQ54941 attached to this Resolution as Exhibit A and incorporated herein by reference for the purchase price of \$105,653.00; and
- WHEREAS: Funding to purchase the crack sealer is available from the 2022 BIA Tribal Transportation Improvement Program (TTIP) funding received by the Nation; and
- **WHEREAS:** The Council has determined that it is in the best interest of the Nation to purchase the crack sealer for the Nation's Public Works Department.
- **NOW THEREFORE BE IT RESOLVED** that the Yavapai-Apache Tribal Council, in Council assembled, at which a quorum is present, hereby authorizes the Nation to purchase the crack sealer from Crafco Inc. as described in Quote #BBBQ54941 attached to this Resolution as Exhibit A for the purchase price of \$105,653.00.
- **BE IT FURTHER RESOLVED** that funds from the 2022 BIA Tribal Transportation Improvement Program (TTIP) shall be used to pay the purchase price.
- **BE IT FINALLY RESOLVED** that the Chairwoman and Vice-Chairman, or either of them, are hereby authorized to take such further action as deemed necessary to carry out the intent and purposes of this Resolution.

Chapter 3 Warranty Information

3.1 Warranty Claim Instructions
