- WHEREAS: The Yavapai-Apache Tribal Council ("Council") is authorized to represent the Yavapai-Apache Nation ("Nation") and act on all matters that concern the health and welfare of the Nation, and to make decisions not inconsistent with or contrary to the Constitution of the Yavapai-Apache Nation ("Constitution") as provided by Article V (a) of the Constitution; and
- **WHEREAS:** The Council, as the legislative body of the Nation, is authorized to enact laws, ordinances and resolutions incidental to the exercise of its legislative powers as provided by Article V(v) of the Constitution; and
- WHEREAS: The Council is authorized to negotiate with other governments, manage the economic affairs of the Nation, and appropriate and regulate the use of the Nations funds, all as provided under Article V(b), (i) and (k) respectively of the Constitution; and
- WHEREAS: The Nation administers certain services for the Nation's elderly members under a grant from the Inter Tribal Council of Arizona ("ITCA"), as authorized under Title III of the Older Americans Act ("OAA"); and
- WHEREAS: ITCA has notified the Nation that the Nation's OAA Funding Agreement has been amended for the period July 1, 2023, through June 30, 2024, to provide funding during that period in the amount of \$24,700.00, as reflected in the Notice of Grant Award No. YANAAAFY24-00 attached to this resolution as Exhibit A; and
- WHEREAS: The Council finds it in the Nation's best interest to approve the attached Notice of Grant Award under the Nation's OAA Grant with the ITCA, in the form attached to this resolution as **Exhibit A**.
- **NOW THEREFORE BE IT RESOLVED** that the Yavapai-Apache Tribal Council, in Council assembled, at which a quorum is present, hereby approves the Notice of Grant Award YANAAAFY42-00 between the Nation and ITCA under the Nation's OAA Title III Grant with ITCA (attached hereto as **Exhibit A**).
- **BE IT FINALLY RESOLVED** that the Chairwoman, and Vice-Chairman, or either of them, are hereby authorized to take such further action as deemed necessary to carry out the intent and purposes of this Resolution.
