All vendors will be assigned a 10'x10' space during check-in. Vendors may not leave their vehicles parked next to their vendor space for the duration of the event (with the exception of Food Trucks & Trailers used for sale of goods). We ask that you park your vehicle in the designated vendor parking lot once you have finished unloading.

VENDOR AGREEMENT

- Vendors are responsible for their own shade, tables, electric/generators, lighting, and equipment.
 - Vendors must keep their vendor space & surrounding areas clean at all times.
 - All Food Vendors must have at least one person in their group who has a valid **Food Handlers Certification**.
 - Food Vendors must dispose of all waste materials properly, including cooking oil.
 - Novelty Vendors are prohibited from selling stink bombs, weapons, firecrackers, pornography or other material deemed inappropriate by the YAN Exodus Committee.
 - Yavapai-Apache Nation Members requesting a vendor booth must be actively working in the booth at all times.
 - Absolutely no alcohol or drugs are permitted on premises.
 - **Applications must be received no later than Friday, February 14, 2025.**
