### REQUEST FOR PROPOSAL (RFP) – CONSTRUCTION SERVICES FOR THE YAVAPAI-APACHE NATION LIMITED PARTNERSHIP #10 and HELPING HANDS

Utilities and Roadway

RFP Release Date 12-12-2025

The Yavapai-Apache Nation Tribal Housing department (YANTH) is actively constructing new homes and community amenities. Limited Partnership #10 is a 37-unit new home project. Helping Hands is a 3-unit home project adjacent to the TC10 and TC9 projects with Dry Well and associated drainage. YANTH is soliciting proposals from qualified firms/individuals for Construction Services related to the Underground Utilities and Roadway. The prepared civil, building and construction plans are available for review at the Tribal Housing office located at 1500 E. Cherry Creek Road in Camp Verde, AZ, or available for printing at Lois Blueprints in Cottonwood, AZ.

**A Pre-Bid Orientation will be held Thursday, December 18, 2025 at 8:30 am. Location: Tunlii Community Center 1520 E. Cherry Creek Road in Camp Verde, AZ.**

#### **I. PROJECT DESCRIPTION**

The housing project is located on the Yavapai-Apache Nation Reservation near the intersection of Hwy 260 and E. Cherry Creek Road in Camp Verde, AZ. More accurately, the homes will be adjacent to Limited Partnership #9, which is currently under construction. Funding for this project is being provided through our Low-Income Housing Tax Credit #10 award, and a State Housing Trust Fund award.

## II. SCOPE OF WORK

The submissions in response to the RFP ("the Proposal") must meet the objectives and the functional requirements of the Scope of Work. Below is a basic list of objectives that must be minimally met.

1. Supply and install underground sewer and testing as per drawings provided by the Civil Engineer.
2. Supply and install the underground water main and testing as per drawings provided by the Civil Engineer.
3. Grade and install roadway and sidewalks/gutter as per drawings provided by the Civil Engineer.
4. Supply and install all signage and striping and speed bumps as per drawings provided by the Civil Engineer.
5. Staking will be provided by YANTH using licensed Surveyor.
6. Supply utilities at the cul de sac at the end of the TC10 project on a separate bid sheet. (Water, Sewer, meter box, meter, curb stop)
7. Supply and install the cul de sac roadway, curb and gutter, sidewalk as part of the TC10 project.
8. Supply and install all meters and meter boxes at the nearest side walk elevation to the top of box.
9. Provide and install curb stop, meter, a 1" stub for the home with a ¾" tee for the irrigation. The prv will be supplied by the plumber and installed in the garage.
10. Supply and install 4" two-way cleanout on the sewer line to each unit for the plumber to connect to. Clean outs will be cut to finish grade after finish grade is established.
11. Delete and do not install any sewer backflow device on any of the units.
12. Supply and install an 8" sewer stub that drains into Pmh-6 next to the water main stub out next to lot 122.
13. Provide and install a direct burial corp. stop from the water main to each lot.
14. Add a 4" sewer stub between lots 89 & 88 near the 4" water stub on the plans.
15. Add a 4" sewer line between lots 115 & 116 next to the 4" water stub on the plans.
16. All inspections will be per Civil plans and inspected with YANTH prescribed inspection firm; contractor is responsible to coordinate appropriate inspections.
17. Proposal to include all pipe, fittings, drain boxes, sleeves, excavation and appropriate bedding, backfill and compaction.
18. Must coordinate inspections with YANTH inspector before any of the utilities are covered up.
19. Any deviation from the approved materials shall be approved in writing by YANTH, the Project Civil Engineer, or other designated entity.
20. No hole will be left overnight or unattended in a roadway or walking surface that is not marked and covered to prevent accidents

21. Comply with all rules and regulations of health, public, and/or other authorities controlling or limiting the methods and materials to be used, or the actions of those engaged in this kind of work.
22. Contractor shall comply with all tribal and federal regulations applicable to project. Although the awarded contractor will perform the civil work for both TC10 and Helping Hands, we will need separate bids and billing for each project. The Helping Hands portion will be the roadway in front of the Helping Hands homes from TC9 to old 279

### III. PROJECT CONSTRUCTION REQUIREMENTS

This project has been designed and engineered prior to this advertisement and all drawings and specifications provided outline the necessary requirements to successfully complete the project.

YANTH's Project Manager or Site Foreman shall be responsible for ensuring communication between necessary parties.

**Please note that Yavapai-Apache Sand & Rock must be your sole source for concrete and shade materials.**

#### **IV. PROJECT TERMS & CONDITIONS**

Please see the sample Contract that is included with this RFP. This contract outlines the agreement between the contractor and YANTH, including but not limited to the Scope of Work, Duties, Rights, and Responsibilities, Contract Sum, Insurance requirements, Retainage, Governing Law, Warranty, and TERO compliance.

Note: The following items constitute a general description of the terms and conditions applying to this project:

- Native American Preference. Preference in the award of contracts shall be given to Indian-owned firms.
- Notice of Award. YANTH will issue a Notice to Proceed after terms and conditions are finalized and the contract is approved by Resolution.
- Performance and Payment Bonds: are not applicable to this project.
- Start Date and Final Completion Date. YANTH will include in the Notice to Proceed.
- Materials Submission. The Construction Contractor will be required to forward proposed material to YANTH for final approval. (Corrugated Metal Pipe and any other drainage pipe called out on the plans).
- Project Retainage. Per the Financial Procedures of YANTH, 5% of all construction contract payments will be withheld as assurance of proper performance of the contract.
- All change orders, including time and material change orders, must be approved by YANTH and must be in written format.
- Davis Bacon Labor Rates are not applicable to this project.
- Tribal Employment Rights Ordinance. The Construction Contractor agrees to comply with procedures set forth in the Tribal Employment Rights Ordinance ("TERO") of the Yavapai-Apache Nation, a copy of which is attached to this RFP.
- Eligible Workers. The Construction Contractor shall ensure that all employees complete the I-9 form to certify that they are eligible for lawful employment under the Immigration and Nationality Act (8 USC 1324a) and shall comply with regulations regarding certification and retention of the completed forms.

#### **V. SELECTION & EVALUATION CRITERIA**

All bids will be opened by our staff at 9:00 am the day after the deadline for submission, with an impartial witness present. This will be a public opening, so attendance is optional. The location will be the Housing office located at 1500 E. Cherry Creek Road in Camp Verde, AZ. All reasonable bids will then be qualified prior to the award announcement.

Qualification will include Indian Preference (if applicable), references, experience with tribal and/or similar projects, and construction details (start date, length of construction, etc.)

## VI. SUBMISSION INFORMATION

Please follow the guidelines set forth below when submitting bids:

- Bids will be due at our Housing office, located at 1500 E. Cherry Creek Road in Camp Verde by Thursday, January 8 at 4:00 pm AZ time. Emailed bids will be accepted at the following email addresses:

It is extremely important for you to confirm that we have received your email submission, as firewalls sometimes block emails from getting through.

- Job title should be "Yavapai-Apache Nation Limited Partnership #10 and Helping Hands – Utility & Roadway bid".
- **BID SCHEDULE:** Each project must have separate bids: TC10 and Helping Hands and underground utilities in the cul de sac at the end of TC10. All items must be bid separately and clearly marked.
- Each bid shall have:
  - Mobilization (the upfront money to start the project)
  - Sewer supply and install (including clean outs cut to grade)
  - Water supply and install (including meter and meter box)
  - Roadway & asphalt (including cul de sac at the end of TC10)
  - Signage and any striping/ speed bumps
  - Curb and gutter & sidewalks
- Do not include any sales tax in your costs – the Nation does not pay sales tax on jobs within its boundaries. AZ Form 5000 will be provided to those contractors receiving construction awards.
- If you would like to be considered for Indian Preference, please submit documentation showing that your business is 60% or more Indian-owned. Documentation shall include organizational documents showing ownership structure along with CIB.
- Do not include TERO fees in your bid – this will be determined at a later date.

- All bids are to be sealed and submitted with the following information included:
  1. Contact name, address, telephone number, and e-mail address
  2. Detailed description of skills, experience, and ability to meet project requirements
  3. Estimated quantities of materials being used
  4. Statement of acceptance, ability, and willingness to enter into a Construction Services Contract
  5. Estimated duration for project completion
  6. Total price with all labor, materials, and miscellaneous costs included
  7. Available to start date
  8. List of client references including project type, construction dates, and description of work completed
  9. Copy of AZROC relevant information including ownership, company structure and disciplinary actions
  10. Documentation that shows qualification as an Indian-owned business, if applicable
