Terms and Conditions

1. I understand that I will be given a (10x10) space at the event but will provide my own table, chairs, shade and any/all other items that I may require
2. A donated item from the vendor is requested of all Arts and Craft and Food Vendors and shall be given to the Environmental Protection Department on the day of the event. Any food vendors requesting to sell food must hold a valid **Food handler's Card** or be supervised by a person on the premises who holds a card
3. Vendor hereby agrees to hold harmless and indemnify the Yavapai- Apache Nation, the event sponsors and the planning committee, employees, agents and volunteers from and against any and all loss, cost, expense, damages, suits, cause of action,, attorney's fees and any and all other cost or expenses arising out of the performance of the Licensee, his officers, agents, servants, and employees including but not limited to any alleged independent liability of the Yavapai-Apache Nation, the event sponsors or the Committee's alleged failure to supervise exhibitor
4. The Yavapai-Apache Nation Environmental Protection Department assumes no responsibility for any property stored or placed on the premises, such property being stored or placed at the vendor's risk. Vendor releases the Yavapai-Apache Nation, and agrees to save the Environmental Protection Department harmless, from liability because of loss, damage to such property resulting from any cause whatsoever
5. The personal conduct of vendor, his agents or employees shall at all times, while on any grounds controlled by the Nation, conform to socially acceptable standards of conduct and any departure there from will constitute grounds for immediate removal of the individual from such grounds and cancellation of this agreement by the Nation. I understand that I am not allowed to carry or possess any weapons, controlled substances, or paraphernalia of any kind. If any of these items are discovered, the person(s) responsible will be asked to leave and the Yavapai-Apache Police Department will be notified immediately.
