Entertainment Agreement

This Entertainment Agreement (“Agreement”) is made and entered into this _____ day of _____, 2026, by and between _____ (“Contractor”) and the Havasupai Tribe (“Sponsor”).

- I. **Performance of Duties:** The Contractor shall provide the services of Entertainer at the 26th Annual Gathering of the Pai Festival hosted by the Havasupai Tribe to be performed at the Sponsor’s venue for the dates of June 5th and 6th, 2026 pursuant to the terms and conditions of this Agreement.
- II. **Compensation:** As compensation for such services and performances, the Sponsor shall pay the sum of \$500. The Contractor shall be responsible for all applicable federal, state, tribal taxes including personal, corporate and/or employment taxes. The Sponsor will pay the Contractor by check on or before June 6, 2026.
- III. **Inability to Perform:** If the Contractor is unable to perform due to sickness, transportation and/or acts or measures within the control of the Contractor and payment has been made to the Contractor, the Contractor shall reimburse the Sponsor the amount paid to the Contractor on a pro rata basis. For example, if Contractor is paid \$500 for services for 2 performances (\$250 per performance x 2 performances = \$500) and Contractor fails to perform on scheduled performance time and date, the Contractor must reimburse the Sponsor \$250.
- IV. **No Transfer of Contract:** This Agreement shall not be assigned or transferred by Contractor without prior, express and written consent of the Sponsor.
- V. **Status of Contractor:** The Contractor is an independent contractor and shall not be deemed an employee of the Sponsor.
- VI. **Notices:** All notices and modifications to be given and communicated between the parties shall be in writing and addressed to the parties.
- VII. **Termination:** This Agreement may be terminated in whole or part in writing by either party with or without cause only when the other party is given not less than 5 calendar days written notice (delivered by certified mail, return receipt requested or hand-delivery) of the party's intent to terminate.
- VIII. **Governing Law and Forum:** The Contractor consents and agrees that this Agreement shall be governed by, construed and enforced in accordance with the laws of the Havasupai Tribe. The Contractor further consents and agrees that the Havasupai Tribal Court shall have exclusive jurisdiction over any claims arising from this Agreement.
- IX. **Confidentiality:** All information received in performing this Agreement shall be considered nonpublic and confidential. Contractor shall not disclose any information



received pursuant to this Agreement, unless the Nation approves disclosure by express written approval.

- X. **Indemnification:** The Contractor hereby agrees to defend, indemnify and hold harmless the Sponsor and all of the Sponsor's departments, agencies, officers, agents and/or employees from all claims, losses, suits, damages, liabilities and expenses of whatever kind or nature, including reasonable attorney's fees, arising out of or resulting in any way from any negligent, reckless or intentional act, error or omission or mistake of the Contractor or any person employed by Contractor, or anyone for whose acts the Contractor is legally liable. Further, the Sponsor shall not be responsible for any loss or damages of Contractor's personal property.
- XI. **Compliance with Havasupai Tribal Laws:** The Contractor hereby agrees to comply with all applicable laws of the Havasupai Tribe.
- XII. **Authority.** The person signing this Agreement warrants and agrees that they have authorization and authority to do so on behalf of the Contractor and/or entity.
