This report is a snapshot of your water quality. Included are details about where your water comes from, what it contains, and how it compares to standards set by regulatory agencies. We are committed to providing you with information because informed customers are our best allies.

Do I need to take special precautions?

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. Where does my water come from?

Your water comes from 2 ground water sources. Two ground water sources are purchased from Public Water System #AZ0413015.

Why are there contaminants in my drinking water?

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity including:

- microbial contaminants, such as viruses and bacteria, that may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife;
- inorganic contaminants, such as salts and metals, which can be naturally occurring or result from urban stormwater runoff, industrial, or domestic wastewater discharges, oil and gas production, mining, or farming;
- pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses;
- organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems;
- radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Special Statements

Educational Statement for Lead

Lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Yavapai Apache - Camp Verde is responsible for providing high quality drinking water and removing lead pipes, but cannot control the variety of materials used in plumbing components in your home. You share the responsibility for protecting yourself and your family from the lead in your home plumbing. You can take responsibility by identifying and removing lead materials within your home plumbing and taking steps to reduce your family's risk. Before drinking tap water, flush your pipes for several minutes by running your tap, taking a shower, doing laundry or a load of dishes. You can also use a filter certified by an American National Standards Institute accredited certifier to reduce lead in drinking water. If you are concerned about lead in your water and wish to have your water tested, contact your water utility. Service Line Inventory for Systems with All Non-Lead

Yavapai Apache - Camp Verde was required to complete an inventory of service line materials to determine whether any service lines connected to the distribution system are made of lead material. We determined that all service lines at Yavapai Apache - Camp Verde are made of non-lead materials. The service line inventory is available upon request, please contact us for more information.

Microbiological Testing

We are required to test your water regularly for signs of microbial contamination. Positive test results could lead to follow-up investigations called assessments and potentially the issuance of public health advisories. Assessments could lead to required corrective actions. The information below summarizes the results of those tests.

Sanitary deficiencies are defects in a water system's infrastructure, design, operation, maintenance, or management that cause, or

may cause interruptions to the "multiple barrier" protection system and adversely affect the system's ability to produce safe and reliable drinking water in adequate quantities.

The following is a listing of significant deficiencies that have yet to be corrected. Your public water system is still working to correct these deficiencies and interim milestones are shown, as applicable.

Deficiency Title: Lack of Functional Distribution Valves

Date Identified: 2/14/2020 Overall Due Date: 9/30/2023

Deficiency Description: The system is has by leaks and breaks in old thin-walled PE service lines. Because of a lack of functional gate valves in the distribution system, water often has to be shut off at the consecutive connection in order to make repairs. This leads to loss of service and positive pressure and the risks of backsiphonage and distribution system contamination.

Corrective Action Plan: Repair, replace and install, as necessary, new gate valves in the distribution system. Enough functional valves should be put in place to ensure that only small sections of the distribution system would have to be shut down in the event of leaks and main breaks. The shut-down areas should be small enough that it becomes practical to continue providing affected homes water service through their outside hose bibs.

Milestone completed by 3/6/2019

Corrective Action Notes: The YANTUA has secured IHS funding to replace a section of distribution lines and install new isolation valves in the distribution system. YANTUA plans to apply for additional funding to complete the Phase 2 valves replacement in the Fall 2019.

Milestone completed by 6/11/2020

Corrective Action Notes: YANTUA has secured EPA fund to replace/install valves.
